MR. FRANKLIN COOK will be Chairman of the Missiology and Human Relations Department. Dr. Mildred Wynkoop has resigned from that assignment, which she has fulfilled so well in instituting the department. She had requested a replacement as soon as possible in order that she might continue her work in Theology. This next year she has accepted the assignment to write a history of Trevecca for the 75th Anniversary.

DR. JAMES CALDWELL, with a number of years of public school experience as a classroom teacher and as counselor, will be Acting Chairman of the Education Department. Dr. Pennington had agreed to help us this past year and we have appreciated his assistance, which was added to his heavy load as Director of Teacher Education and Workshops.

DR. ROBERT HOWARD has been appointed Acting Chairman in the Fine Arts Department. He joins the staff from Asbury College. He replaces Dr. Larry Patterson who is taking an assignment at CNC.

DR. PAUL CLECKNER has been appointed Chairman of the Communication Department (which is a new department this year). While the curriculum has been established for the fall term, we want to give that new department chairman the privilege of changing the curriculum program or other department activities to best meet the institutional goals.

"Pioneer" Explores Possibilities For New Year at TNC

A new food service will come to Trevecca in September: "Pioneer", owned by Byron Hall, a former employee of Saga Food Service. Its first year in operation, "Pioneer" has been well accepted at Mount Vernon Nazarene College, the only college it serves at the present time. It was liked so well, in fact, that the signing of a two-year contract with that college has just been approved.

Its main way of keeping student interest and satisfaction at peak levels is through the use of "monotony breakers," coming periodically at about the rate of every 10 days in addition to monthly and holiday specials. An idea used at MVNC, some of the things this could include are: a birthday club where punch and coffee would be served when a student had a birthday; serving a supper of steak

and eggs to the basketball team prior to home games; pancake-eating contests; breakfast buffets, etc. In this way a variety of food is created, rather than just serving the same old "hamburger-and-fries".

One of its main policies is that of keeping an "open door", always being willing to listen to the complaints of students and to answer them as well as possible. At Mount Vernon, a suggestion box was used for this, and questions were answered daily. They feel that, if given the chance, they can adequately meet the needs and desires of the students. However they cannot do so unless they know what the students do want.

Mr. Hall, "Barney," previously operated a drive-in restaurant in Mount Vernon known, obviously, as "Barney's Drive-In." He has worked in the food service business

for eight years.

Mr. Stan Kasakevics, who would be food service director here in the fall, also has a wealth of experience behind him. Presently, he is serving as food director at Ohio Wesleyan (Delaware, Ohio), with eight managers under him. Their cafeteria system serves approximately 1800 of the 2600 students that attend college there, so he should adequately be able to

manage a student body the size of Trevecca's. Altogether he has been in the food business twelve years.

Because "Pioneer" is small, it can give each person and each problem more individual attention. With their service, plus the redecorating of the cafeteria to be done in August (new carpet, paint, etc.), TNCer's should get off to a "healthy" start for the '74-75 school year!

Dear Editor:

I am writing to express my concern over the "religious" article in your most recent issue of TREV-ECHOES, titled, "Revival Afterthoughts." First of all, let me say that as far as a number of the students, including myself, could see, Mike Mort's afterthoughts had nothing to do with revival. It was a mere summarization of Mike's talk in chapel. Although Mike and I are friends; although we traveled

often together in the college quartet; although I was one of the student evangelists, too; and although his message was well prepared and well delivered (much better than mine!), I personally feel that overall, it greatly hindered the spirit of unity and revival that was so very needed on campus.

Mike's "Revival Afterthoughts" were a cheap and false representation of the new life in Christ that is free for all to experience. Jesus died to give us a whole new way of living, and revival is directly related to that new life. Mike's article expressed nothing of genuine revival.

I do not have time neither do you have space for me to give a rebuttal to all of Mike's views, but permit me to mention two.

1. - Prayer is talking and communicating with God. Although we can communicate with God at all times, and walk in a spirit of prayer--there is still a time, place, and purpose for actual dialogue with God. His idea is almost as ridiculous as me saying that I never have to speak to my wife in order to communicate with her effectively. I can't tell, let's say

when I begin to talk with her and when I finish. What kind of love relationship would that be? Ours is supposed to be a love relationship with Him.

2. - What need I say concerning the concept of church being a good place to go if one has nothing better to do? It reflects a number of misconceptions, chiefest among them: the whole idea of what church is all about to begin with. Is church meant to be a "nice" place to go? Or is it a place where we go to be "good". No! Church is a place where we go to communicate and have fellowship. If Mike knew as much about Life as Cathy Ray claims she does, he would realize what a vital part church plays in the life of people who do not know as much about God and the Bible as he does; or those who have no home, or campus, or any other place where Christian communication and fellowship is available. And who is it that is such a "super-Christian" that he does not need Christian communication and fellowship?

All in all, I felt Mike's column in the last issue to be a tragedy. It certainly does not reflect the general feeling of the student body and most certainly is not a biblical view of revival. If revival is from God (I think we still believe that), and if the Bible is God's word, I fail to see how a non-biblical message or religious column can do anything to generate a spirit of revival or any revival afterthoughts.



As much as Christians, especially Nazarene Christians, hate to admit it, Trevecca is rapidly outgrowing its present security force because of our location in a high crime-rate district.

There were times in the not so distant past (summer, fall 1973) when routine hourly patrols of five to fifteen minutes were sufficient for our Holy Hill. But, with the repeated breakins of TNC's post office (now being investigated by the F.B.I.) late in the fall quarter through spring 1974 and the constant vandalism of the Benson Building, presently under construction, these practices have become obsolete. The routine patrols have been updated, but the one-man night shift (11 p.m. to 7 a.m.) still remains. TNC's security force has much more to deal with than the locking and unlocking of buildings, giving tickets when deserved, and giving gentle reminders of "no P.D.A." They now deal not only with students but with off-campus offenders whose vandalism has cost Trevecca in excess of \$5,000, since winter, quarter 1974, referring particularly to the Benson Building.

This writer has had opportunity on several occasions to walk patrol with some, if not all, of TNC's security force. There is no place on TNC's campus more frightening to patrol than the Benson Building on a dark, quiet night between 11 p.m. and 7 a.m. The reason being is that the people who are vandalizing Benson are not mere students playing practical jokes; they are grown people looking to make some money through the resale of stolen copper wire, small hand and power tools, and an assortment of other items. These people aren't going to stand still and let some unarmed security guard take them in for vandalism, trespassing, and breaking and entering. These people carry guns and generally will not hesitate to use them on anyone who could possibly rook them out of athis easy money and senddithem to jail, including TNC's security officer who happens to be on duty that night.

What can be done? There is one short term answer and many long term answers.

The building is designed to be lighted outside and also the parking lot is to be lighted eventually--so why not plan ahead and put the lights up now? This short term answer is directed to Mr. Holmes.

Two long term, but quick action answers are (1) clearing the underbrush from Benson to the railroad tracks that provide more than adequate hiding places for these vandals and (2) a two-man security force for the 11 p.m. to 7 a.m. shift, consisting of an armed senior officer and an armed junior officer. The partners would stay in close contact through two-way monitor radio; should one get wounded, it would provide a more efficient force in case of trouble.

Neither Mr. Gore, Dean Lewis, nor even Mr. Holmes can accomplish payment of another officer when there are no funds to work with, and this writer has no quarrel with them on this point. But this is an area where students and their parents can play a great and direct role in getting something done here at TNC. The money control lies in the hands of

Probably one of the biggest events to ever occur on TNC's campus was the ground-breaking of the Trevecca cascades on Thursday, May 16th. Covered by local television and newspapers, it was presided over by the honorable Governor Winfield Dunn of the State of Tennessee. Many distinguished people attended both the preceding chapel introduction and the actual ground-breaking following. Included in this were Mr. and Mrs. Harold Morris, his company, the Apollo Contracting Corporation, assuming chairmanship for the construction of the project. He is a member of the President's Advisory Board (the purpose of which is to raise funds for the college), and they are both members of Nashville First Church of the Nazarene.

Other participants in the ceremony were Dr. and Mrs. Mark R. Moore, Dr. and Mrs. Stanton Parry, Chaplain Neil Wiseman, Prof. James Jarrett, Mrs. Nona Owensby, and various members of the Student Council and the Campus Improvement Committee.

Gov. Dunn's chapel talk concerned the upgrading of higher education, particularly in Ten-

nessee, and the advantages of going to a college with a spiritual emphasis. Acting as a backup group, the combined Chapel Choir and Concert Choir sang a glorifying rendition of "Battle Hymn of the Republic." The most memorable point, however, was Dr. Moore presenting the governor with a bronze engraved portrait of an elephant (done by Dag Thomas, one of the foremost of African artists) to represent the "power and strength" of the Republican party.

The actual strength of the Republican party could really be seen when the earth-turning for the cascades began, being led by Gov. Dunn. Using a gold shovel, he struck "pay dirt" in the form of a..worm???

Anyway, the entire ceremony was something that will remain a landmark in Trevecca's history and is a grand introduction to our coming 75th anniversary in 1976. Surveying for the construction has already begun so the project will hopefully be complete by fall. We owe our thanks to First Church and its people for financing such an addition and helping make Trevecca's campus really "something extra!"
